Minutes of the meeting of the Parish Council
held at the recreation centre on Tuesday 27th February 2024 at 7.30pm

- 1. Open Forum – An opportunity for any parishioner to speak on parish matters and to hear reports from District and County Councillors, if applicable** – There was none.
- 2. To consider and approve apologies for absence** – Apologies had been received from Robin Croft and Ashley Broughton.
- 3. To complete the co-option process of two successful applicants** – Cllr S Southcott signed his declaration of acceptance of office.
- 4. To receive any declarations of interest in any item on the agenda** – Cllrs S & H Mellor declared an interest in item 8b.
- 5. To confirm the minutes of the meeting of 15th November 2023** – The minutes were confirmed as a true record of the meeting and were signed by the Chairman.

Mark Hadley and Ms Taylor advised that Breckland Council would now be notified of the vacancy, following which a notice would be published allowing 14 days for 10 electors to request to hold an election to fill the vacant position and, should this period pass without such a request being made, the Parish Council will fill the vacancy by co-option.
